MI BASICS

While practicing MI, a practitioner or a coach/supervisor may demonstrate a particular style of communication. Read more below to see examples of verbs associated with each style:

- **Directing**-focuses on giving info and advice
- **Guiding**- ideal for honoring autonomy and evoking change
- **Following**- focuses on good listening

When asked what works for you when coaching, one FL MI Supervisor encourages others to “be honest, listen to your caseworkers, and respect their time.”
